Intended Use

A mounting support, to equip the anesthesia device Fabius GS onto a ceiling supply unit in rooms used for medical purposes.

The application of a ceiling mounting support is designated for buildings, not for mobile facilities such as ambulances, helicopters or vessels.

Any use of the device requires full understanding and strict observation of these Instructions for Use. The device is only to be used for the specified purposes.

Maintenance

Repair and general overhaul of the device may only be carried out by trained service personnel. We recommend that a service contract be obtained with DrägerService and that all repairs also be carried out by them. Only original Dräger spare parts may be used for maintenance.

Fabius GS as a ceiling device

Characteristics

In connection with the ceiling supply units DVE 603X or DVE 808X, the anesthesia device Fabius GS can be used as a ceiling device.

The ceiling supply units can lift the anesthesia device Fabius GS by using the "equipment holder M" and the belonging control unit for the lift.

Coupling the Fabius GS onto the DVE

- For Movita 603X: see Instructions for Use of Movita 600X/ 603X (order no.: 9037479), chapter "Coupling of the Julian or Mova Cart trolley". The coupling of the Fabius GS is carried out identically.
- For DVE 808X: see Instructions for Use of DVE 8080/ 8081/8082 (-C/-M), order no.: 9029046, chapter "Julian or other devices on the ceiling supply unit DVE 808X-M".
 The coupling of the Fabius GS is carried out identically.
